

The Bupa Breast Cancer Project October 2016

Terms & Conditions

1. The Bupa Breast Cancer Project (The BBCP) has been set up to help provide women who have lost their hair due to cancer treatment with wigs. All the hair that is donated by participants will be passed on to Action for Breast Cancer Malta to produce wigs through Community Chest Fund.
2. The BBCP will be giving out 150 FREE haircuts at any of the participating Dean Gera Hair Care outlets throughout Malta to the first 150 eligible participants who would like/ is able to donate their hair, and ONLY IF it fits the criteria mentioned in these terms & conditions (please refer to point no. 3 below).
3. The criteria for the hair required is as follows: 1. All hair colors are accepted including gray. 2. No bleached hair is accepted. 3. Hair must not be over-processed and preferably naturally colored. 4. Must have a minimum of 8 inches (tip to tip) of hair to donate. 5. Only natural human hair is accepted; no wigs, extensions, or synthetic hair. The hair and scalp must be in a suitable condition for the hair to be used by Action for Breast Cancer Malta. The criteria for hair is set by The BBCP and The BBCP shall have absolute discretion to determine whether hair meets the required condition for use by Action for Breast Cancer Malta. The BBCP shall be free to determine that hair is not acceptable for such purpose.
4. This project will begin on 03 October 2016 and will end once 150 eligible applicants have been confirmed, or by 03 November 2016 at the latest (regardless of whether all 150 haircuts have been awarded).
5. This project is not limited to Bupa Malta customers only. It is open to the public and applicable for the first 150 eligible applicants on a first come, first serve basis. If the participant is under the age of 18 at the time of entry, a legal guardian must approve entry in writing.
6. The free haircut will be available for the first 150 eligible persons who apply by filling in a short form on the company website www.bupa.com.mt. Should you wish to find out more details/ information you may also E-mail on info@globalcapital.com.mt or call on 21 342 342 during the whole month of October 2016.
7. Once the applicant is deemed an "eligible participant" (please see point no.3), the next step would be for a representative of The Bupa Breast Cancer Project to forward the applicant a voucher by E-mail within a maximum of 3 working days and once the voucher is at hand, the applicant is asked to contact any one of the participating Dean Gera Hair Care salons to book an appointment. The voucher is to be presented at the hairdresser appointment. If E-mail is not used by the applicant the company could forward the voucher by post at no extra cost. (For further company details please see point no.6).
8. The voucher issued to be redeemed at Dean Gera Hair Care can be used on any stylist apart from directors of the company.
9. The haircut appointment must be made during October 2016 and the voucher is to be redeemed by 31 December 2016. The voucher cannot be used on public holidays, Christmas Eve or New Year's Eve.
10. No cash alternative is available. Participants must bear own costs for any related participation costs, including travel.
11. Bupa Malta is not liable for any aspect of the haircut provided by Dean Gera Hair Care, including, but not limited to, service, quality and supply.
12. Entry confirms acceptance of these terms and conditions. This project and these terms and conditions shall be governed and interpreted in accordance with English law.
13. Bupa Malta reserves the right to alter or suspend this project at any time without notice.
14. Bupa Malta reserves the right to substitute alternative prizes which may not be of equivalent value at any time by notifying the winning applicant.
